The Transforming Rehabilitation Consultation

The consultation is now closed, yet it would appear that the die is cast. Probation are being stripped of the central role they have played for so long in reducing re-offending. They will be left as a narrowly-focused organisation dealing with, amongst other things, the risk assessment process for offenders, and may well lose many of their best staff.

We remain extremely concerned about the pace of the reforms being introduced, as well as the uncertainties about measurement and outcomes. The widespread adoption of Payment by Results (PbR), represents a radical new departure. We are especially concerned that PbR has never yet been applied to the delivery of community sentences in the UK or anywhere else, and that no one knows for sure how it will work.

Many questions remain unanswered. MJW acknowledges, however, that the reforms may eventually lead to the development of a leaner, smaller, more effective criminal justice system. The main focus should, we believe, be on demand reduction – fewer people in the system, and more rehabilitation work delivered in the community, rather than inside overcrowded prisons.

Payment by Results - Just Results

We were shocked and saddened by the sudden death of Alasdair Liddell, on New Year's Eve. Al was the key person behind the development and implementation of our <u>'Just</u> <u>Results'</u> day, together with his friend and colleague, Dr Greg Parston. We were extraordinarily fortunate to have benefited from his knowledge and expertise, not to mention his support and friendship. He is very much missed by us, and by all his friends and colleagues.

Working with Greg in the 1990s, AI commissioned a simulation exercise known as the 'Rubber Windmill', to explore how the proposed reforms in the health service might work in practice. It enabled managers and clinicians to test mechanisms and behaviours, and develop practices to ensure the new system worked. Importantly, it provided early evidence of the weakness of purchasing (later called commissioning), the potential of GP fund holding (now reborn as clinical commissioning) and the need to take all clinicians, especially those in the acute sector, along with you. It was also evident at the outset that the voice of the patient was not being heard.

We are urging the Ministry of Justice to undertake a similar process before rolling out PbR in the criminal justice sector.
